MINUTES OF THE WORK SESSION CITY COUNCIL OF CREST HILL WILL COUNTY, ILLINOIS May 9, 2022

PUBLIC COMMENTS: There were no public comments.

TOPIC: Self-Evaluation with a Representative of the Illinois Municipal League. Greg Cole from the Illinois Municipal League gave a presentation to the Council.

Mayor Soliman announced that there is a need for an executive session on Self-Evaluation with a Representative of the Illinois Municipal League 5 ILCS 120/2(c)(16)-Self-evaluation, practices and procedures or professional ethics, when meeting with a representative of a statewide association of which the public body is a member.

Ribbon cutting will take place at 11:00 p.m. with activities afterwards.
